It is to discuss the duty of the citizen that we attempt to advance a few thoughts on the subject.

At this time the most that we can do for our country is to see that the neighborhood in which we live is loyal to the nation, in thought, word and deed, and if we find any sore places to do what we can to get the community in healthy condition. We are proud of the fact that in the territory embraced in our horizon that there is not the least sign of disloyalty to the United States, and that every man is ready to do his duty...

Be ready:

- ◆To go anywhere that you have orders to go.
- ◆To do anything that the powers that be require of you.
- ◆To give up any part of your means that is considered necessary by the powers that be to bear the expenses of the campaign. Sometimes to gain all, we must risk all.

Be diligent:

◆To produce wealth to support the nation throughout the war. Plant more. Work more...

◆To bridle the tongue if inclined to criticise that which you do not fully understand and thus embarrass the government.

◆To keep down and discourage seditious utterances in others.

◆To inculcate in the hearts of the young the blessings of a free country. Freedom is now menaced as never before.

◆To let every man who is called to the front, know before he leaves that his family and affairs will receive the most careful and considerate attention while he is away on the nation's business.

Smedley Butler

United States Marine Corps General, 2 time Medal of Honor recipient and activist

Smedley Darlington Butler (July 30, 1881 - June 21, 1940) was the United States Marine Corps major general, the highest rank authorized at that time, and at the time of his death the most decorated Marine in U.S. history.

Butler exposed the *Business Plot*, an alleged plan to overthrow the U.S. Government. A final report confirmed some of Butler's testimony.

Major General Smedley Butler, "In the World War I a mere handful garnered the profits of the conflict, at least 21,000 new millionaires and billionaires were made in the United States during the world war. That many admitted their huge blood gains in their income taxes. How many other millionaires falsified their tax returns no one knows"

Hermann Goering

German politician, military leader, and leading member of the Nazi Party.

Hermann Wilhelm Goering (January 12, 1893 - October 15, 1946.

After helping Adolph Hitler take power in 1933, he became the second-most powerful man in Germany. He founded the Gestapo in 1933, and later gave command of it to Henrich Himmler. Goering was appointed commander-in-chief of the Luftwaffe in 1935.



Hermann Goering at the Nuremburg Trials, "Naturally, the common people don't want war. Neither in Russia nor in England nor in America, nor for that matter in Germany. That is understood. The people can always be brought to the bidding of the leaders. That is easy. All you have to do is tell them they are being attacked and denounce the pacifists for lack of patriotism and exposing the country to danger. It works the same way in any country."



The people demanded a new constitution. The 1872 Constitution attempted to provide individual and state protections. Has it gotten worse? Since 1950, the year of my birth and the beginning of the Korean “War” (so-called), we have had 17 “unconstitutional wars”, or 80% of my life. [Only Congress Can Declare War]

What do we do with the Declaration of Independence?

With no acknowledgement from the legislative and executive branches, a complaint with over a dozen Writs of Mandamus was filed in the West Virginia Supreme Court of Appeals and assigned Case # 15-0491.

Justices added to Hudok's lawsuit

ELKINS – Three area residents who filed a lawsuit against the state of West Virginia demanding a “constitutional government” be restored within the state have also named all five West Virginia Supreme Court Justices as defendants.

Phillip Hudok of Hutonsville, Gene Stalnaker of Daniels and Thomas Deegan of Mineral Wells originally filed

the suit in May against Gov. Earl Ray Tomblin, Attorney General Patrick Morrisey, Clerk of the West Virginia House of Delegates Steve Harrison and an “unknown private for profit subcontractor providing government services and purporting to be lawful gov-

ernment in operation.”

The filing has since been amended to also include the five Supreme Court Justices for “failing to act because they were in default and dishonor legally.”

Hudok said, in an exclusive interview with The Inter-Mountain this week, he feels the government is abusing its power and making United States citizens enemies of the government.
