The documents for download verify the following three aspects: The scope of this Arbitration Award is without precedent. The Arbitration Act passed a recent test in the Supreme Court. A 2016 Congressional Bill on the private side produced the settlement of an arbitration award that while quite impressive, pales in comparison to Treaty of Peace 2020.

There is a November 1 deadline for opting into the settlement.
