

Affidavit of Truth and Fact

I, Robert-Joseph House of Driskell, was in Washington, D.C. with Phil Hudok, between February 24-28, 2020. Mr. Carsen stated, after reviewing the documents, that yes, he sees that we have an Arbitration and an Arbitration Award. And after making that statement, he suggested we take the Bill and the Award for enforcement before a Federal Court, while also stating the Senator(s) usually like to drag their feet on such things and have not historically written many "Bills", as they do not like to write them. Senator Manchin is the Senator from West Virginia where Phil Hudok and others named, originated the Bill of Peace and also went through the complete Arbitration process, as awarded.
