## First Amendment Petition for a Redress of Grievances and Breach of Contract

- 2. The Immediate and Unconditional Public Severing, Voiding, Cancellation and Repudiation of Any and All ties and contractual obligations with, and to, the UNITED STATES and UNITED NATIONS, both of which are foreign and privately controlled corporations, and a Public Assertion of Absolute Compliance to the Constitution for the United States of America c1819.
- 3. The Complete, Absolute and Unconditional Public Cancelling, Repealing and Rescinding of Any and All codes, statutes, rules, regulations, ordinances, et cetera of the federal territory STATE OF ILLINOIS, State of Illinois, Illinois, et cetera and its subdivisions, instrumentalities and creations, the Constitution of Illinois (earliest version, never ratified by the people) put in place from the twenty sixth day of August in the Year of Our Lord one thousand eight hundred eighteen (1818), to the date of this Petition and Demand, such being an Absolute and Unconditional complete restart and reset to Proper and Expressly Authorized Constitutional Moorings.

### Public Notice of Acceptance and Acknowledgement of Declaration of Independence, Constitutions and Oath(s) of Office

The respective oaths are the public servants **OPEN** and **BINDING** offer of promise to form a firm and binding contract between the public servants, their commercial, military and political instrumentalities and me, myself in my sovereign, private capacity.
