# The United States Of America is a Corporation owned by foreign interests

Since the Act of 1871 which established the District of Columbia, we have been living under the UNITED STATES CORPORATION which is owned by certain international bankers and aristocracy of Europe and Britain.

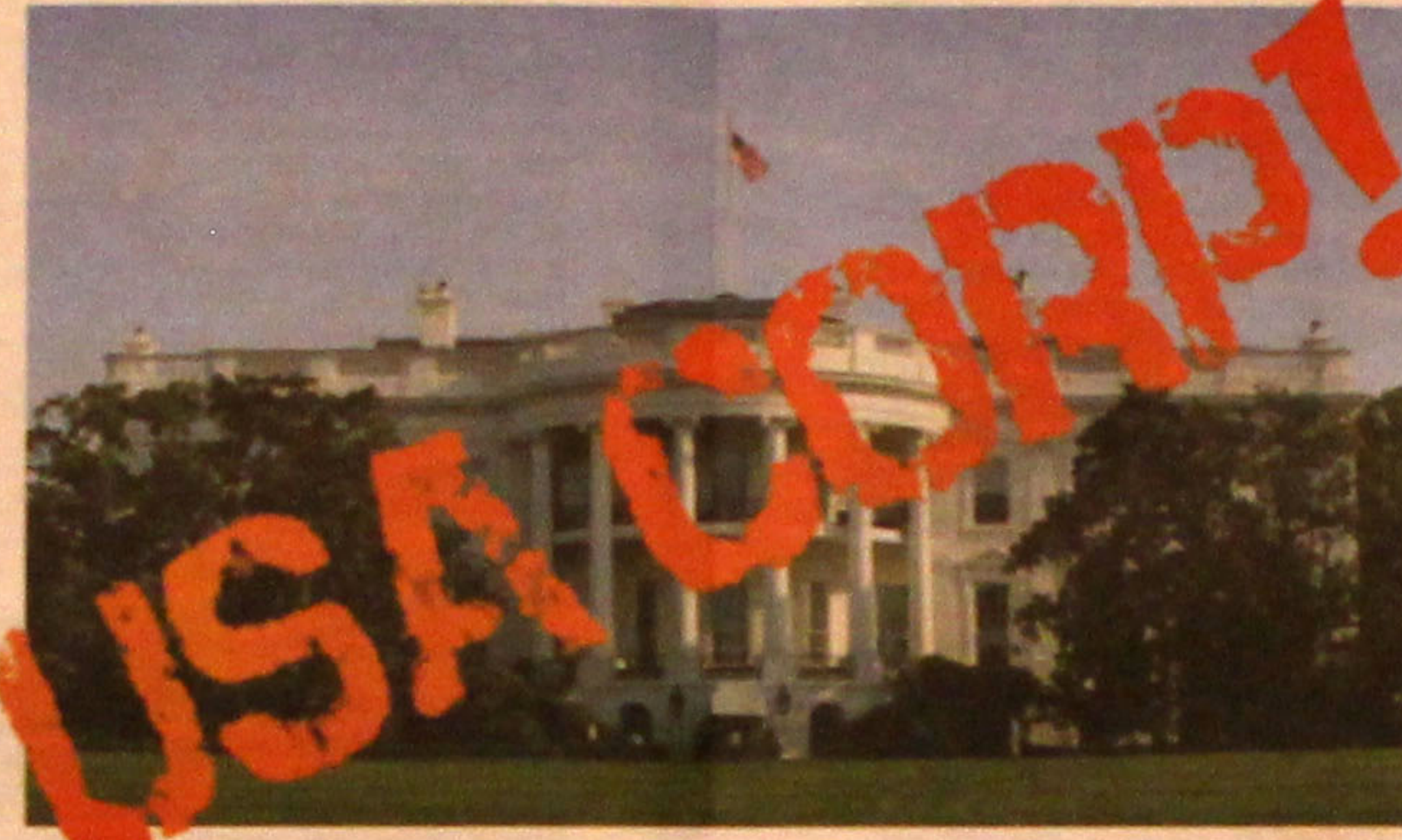

Over time, the Republic took it on the chin until it was knocked down and counted out by a technical KO [knock out]. With the surrender of the people's gold in 1933, the 'common people' was handed over to illegitimate and foreign law. (I'll bet you weren't taught THAT in school.)



Our corporate form of governance is based on Roman Civil Law and Admiralty, or Maritime, Law, which is also known as the 'Divine Right of Kings' and the 'Law of the Seas' -- another fact of American history not taught in our schools. Actually, Roman Civil Law was fully established in the colonies before our nation began, and then became managed by private international law. In other words, the government -- the government created for the District of Columbia via the Act of 1871 -- operates solely under Private International Law, not Common Law, which was the foundation of our Constitutional Republic.

This fact has impacted all Americans in concrete ways. For instance, although Private International Law is technically only applicable within the District of Columbia, and NOT in the other states of the Union, the arms

of the Corporation of the UNITED STATES are called 'departments' -- i.e., the Justice Department, the Treasury Department. And those departments affect everyone, no matter where (in what state) they live. Guess what? Each department belongs to the corporation -- to the UNITED STATES/U.S., Inc.!

Refer to any UNITED STATES CODE (USC). Note the capitalization; this is evidence of a corporation, not a Republic. For example, In Title 28 3002 (15) (A) (B) (C), it is unequivocally stated that the UNITED STATES is a corporation. Translation: the corporation is NOT a separate and distinct entity; it is not disconnected from the government; it IS the government -- your government. This is extremely important! I refer to it as the 'corporate EMPIRE of the UNITED STATES,' which operates under Roman Civil Law outside the original Constitution. How do you like being ruled by a corporation? You say you'll ask your Congressperson about this? HA!!

Congress is fully aware of this deception. So it's time that you, too, become aware of the deception. What this great deception means is that the members of Congress do NOT work for us, for you and me. You are tell by their voting record! They work for the Corporation, for the UNITED STATES. 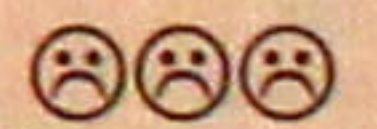

First, 'Of' means "belonging to"... so that 'corporate constitution "belongs" to the United States (the corporation) known as U.S., Inc. Second, "for" is defined as; "with regard or respect to", "in favor of", "in the interest of" the united States (of the Union)... not the 'corporation!

# America is a Corporation owned

In short, our government, which was created by us and for us as the true sovereign power -- free 'people' deemed to have the highest authority in the land -- was stolen from us, along with our rights. of the Corporation of the UNITED STATES are called 'departments' --i.e., the Justice Department, the Treasury Department. And those departments affect everyone, no matter where (in what state) they live. Guess what? Each department belongs to the corporation -- to the UNITED STATES/U.S., Inc.!

Refer to any UNITED STATES CODE (USC). Note the capitalization; this is evidence of a corporation, not a Republic. For example, In Title 28 3002 (15) (A) (B) (C), it is unequivocally stated that the UNITED STATES is a corporation. Translation: the corporation is NOT a separate and distinct entity; it is not disconnected from the government; it IS the government -- your government. This is extremely important! I refer to it as the 'corporate EMPIRE of the UNITED STATES,' which operates under Roman Civil Law outside the original Constitution. How do you like being ruled by a corporation? You say you'll ask your Congressperson about this? HA!!

Congress is fully aware of this deception. So it's time that you, too, become aware of the deception. What this great deception means is that the members of Congress do NOT work for us, for you and me. You can tell by their voting record! They work for the Corporation, for the UNITED STATES. Prior to 1913, most Americans owned clear, allodial title to property, free and clear of any liens or mortgages until the Federal Reserve Act (1913) "Hypothecated" all property within the federal United States to the Board of Governors of the Federal Reserve - in which the Trustees (stockholders) held legal title. The U.S. citizen (tenant, franchisee) was registered as a "beneficiary" of the trust via his/her birth certificate. In 1933, the federal United States hypothecated all of the present and future properties, assets and labor of their "subjects," the 14th Amendment U.S. citizen, to the Federal Reserve System.

In return, the Federal Reserve System agreed to extend THE FEDERAL United States CORPORATION [emphasis added] all the credit "money substitute" it needed. Like any other debtor, the federal United States government had to assign collateral and security to their creditors as a condition of the loan.
