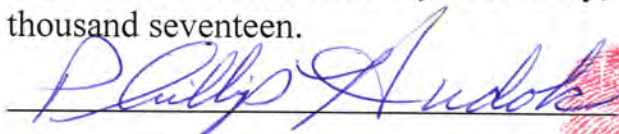

Declaration and Indenture Covenant of a Trust

This instrument shall be interpreted, executed and effectuated under the Laws of the Creator and the Laws of Creation, with the original situs in, on and above:
Earth

under, and out of, the authority of absolute necessity in Private and Original Venue, under Exclusive and Original Jurisdiction and Law Form;

This Trust Indenture does by these Presents authorize the Trustees to perform under the name of:
FREEDOM

and does further hereby authorize the Trustees to design, effectuate and utilize a seal as soon as practically feasible;

This Declaration of a Trust is made on the fourth day of August, in the Year of my Lord Jesus Christ two thousand sixteen, on Sovereign Soil, Under the Laws of the Creator and Laws of Creation by the Almighty Creator, I AM, by and through His Honorable Word, hereinafter Grantor;

Witnesseth:

(A) Grantor had, has and shall continue to have Superior claim to, and interest in, Creation and all contained within, without limitation; By, and pursuant to, Case #'s 11-F-101, 16-F-25 and 15-0491 and any and all documents, papers, digital data, recordings and other tangible items thereto and thereof, and the permanent default, dishonor and forfeiture in law, at law and otherwise, the Grantor, and thereby His Heirs, by and through the Signatories thereto, have re-stated, re-ratified, re-confirmed, re-noticed, re-declared, re-authorized, re-ordered, re-issued and re-established their Lawful and Superior claim to, and interest in, Creation; Further, the Heirs, as holders-in-due-course, real-parties-in-interest, secured parties, grantors, bailors, administrators, creditors, custodians and beneficiaries to, and for, all alleged political, civil, social, corporate, military, commercial and ecclesiastical powers, structures, systems and networks and any and all other limits of any nature, shape, cause, kind, form and format, and any and all variations and combinations thereof, have always held a Superior claim and are by, and through, the Trustees to this Trust Indenture exercising, effectuating and utilizing the same, nunc pro tunc, praeterea preterea, without recourse, without prejudice; Furthermore, the Grantor desires that provisions shall be made for the care, management, disposition, distribution, restructuring, accounting, audit, discharging, payment, settling, closing, dissolving and/or reconciling of the following, to wit:

The soil of what some call the United States of America, inclusive of all real property and all chattels therein, any and all legal, financial and managerial and other instrument(s),

and other tangible items of any nature, shape, cause, kind, form and format, and any and all variations and combinations thereof, any and all legal, financial, managerial and other accounts of any nature, shape, cause, kind, form and format, and any and all variations and combinations thereof, any and all items contained within Comprehensive Annual Financial Reports and like forms and formats, and any and all other assets, without limitation, all for the use, benefit and enjoyment of His Heirs, hereinafter Beneficiaries, in the manner provided hereinafter and those manners the trustees may decide is most conducive to the intention of FREEDOM;

(B) Parties have agreed, subject to His moral terms and contractual terms hereof, to act as Trustees of this Trust; In full consideration of the matters described above and hereinafter, and of the mutual benefits and obligations set forth in this Trust Indenture, the parties sui juris agree as follows, to wit:

Article the First

Classification, Irrevocability

- (1.1) This Declaration of Trust is intended to form an irrevocable Trust in private Venue, under exclusive and Original Jurisdiction and the Creator's Law Form; For the purposes of this Trust Indenture, the Trust shall function in the capacities of an inter vivos, complex, contract and Creator's Law Trust;
- (1.2) The Trust is irrevocable but cannot override the Creator, nor supersede the Original Organic Trust so endowed by the Creator at the moment of the inception of Creation.

Article the Second

Transfer in Trust, Acceptance and Acknowledgement of Trust, Name of Trust

(2.1) Grantor, in consideration of the Trustees acceptance and acknowledgement of the Trust created by this instrument, and the terms and conditions thereof, does hereby convey, transfer, assign and deliver to the Trustees, and their successors in Trust, the aforementioned and hereafter described, to wit: any and all real properties and any and all chattels, any and all legal, financial, managerial and other instruments and any and all other tangible items of any nature, shape, cause, kind, form and format, and any and all variations and combinations thereof, any and all legal, financial, managerial and other accounts of any nature, shape, cause, kind, form and format, and any and all variations and combinations thereof, any and all items contained within Comprehensive Annual Financial Reports and like forms and formats, any and all other assets, without limitation, and that which may, from time to time, be held by the Trustees under the authority and terms of this Trust Indenture, all hereinafter referred to as FREEDOM's assets;

(2.2) Trustees, by their execution of this Trust Indenture, do hereby accept this Trust, and the duties, responsibilities and obligations contained herein, and acknowledges that Grantor has settled upon it those assets set forth above;

(2.3) The Trust constituted by this Trust Indenture shall be known and operate at all places and all times as FREEDOM;

(2.4) In the name of FREEDOM, the Trustees, Trust Officers and

any agents thereof, shall engage in, effectuate and utilize the forfeited alleged governments' and corporations' duties and responsibilities of protecting, securing and furthering all Rights, Privileges, Freedoms, Immunities and Properties of the Beneficiaries, within the herein described Sovereign Soil geographic boundaries, to wit:

The geographic boundaries are the Pacific Ocean to the west, the Atlantic Ocean to the east, the southern border of Canada to the north, the northern border of Mexico to the south, and shall also include those tracts of Sovereign Soil commonly referred to as Alaska and Hawaii;

(2.5) The Trustees, Trust Officers and agents thereof shall engage in all lawful activities deemed to be vital and necessary to carry out the duties and responsibilities, and to further those goals, they may perform all acts they consider vital and necessary in furtherance of any and all such activities; The powers, duties and responsibilities of the Trustees are more specifically set forth in Article the Fourth below.

Article the Third Purposes

The Trustees, Trust Officers and agents thereof shall act to accomplish the following purposes along with any necessary actions to do this as quickly and quietly as humanly possible without in any way, shape or form encroaching on and/or violating the Rights, Privileges, Freedoms and Immunities of any and all Beneficiaries, to wit:

(3.1) Protection of the assets: to prevent unnecessary dissipation of the income or assets of FREEDOM; to preserve the estate;

to maintain asset integrity; to accomplish necessary arrangements to protect and conserve FREEDOM's assets for the Beneficiaries;

(3.2) Continued Furthering of Administrative Trust Purposes: to administer FREEDOM's assets for the benefit, use and enjoyment of the Beneficiaries; to administer services and goods in the nature of government for the benefit, use and enjoyment of the Beneficiaries; to avoid any and all fraudulent associations for any purpose whatsoever; to encourage Stewardship and foster and promote honorable values and concepts; to effectuate the speedy and complete transfer of power and alleged assets from all forfeited alleged governments and corporations operating and/or conducting business with forfeited and dissolved charters back to the Beneficiaries; to provide for the absolute privacy, protection, well being, health, environmental safety, the securing, guarding and upholding of Creator granted Rights, Privileges, Freedoms and Immunities of the Beneficiaries; education on that knowledge which has been hidden from view;

(3.3) Continued Efficient Administration and Management: to secure an efficient administration of FREEDOM; to consolidate all forfeited alleged government and corporate activities, operations and services to efficiently achieve FREEDOM's purposes; to maintain security, privacy, protection, well being and the securing, guarding and upholding of Creator granted Rights, Privileges, Freedoms and Immunities; to operate for the sole use, benefit and enjoyment of the beneficiaries;

(3.4) Continued Furthering of the Administrative Purposes: to provide liability protection, privacy and asset protection from all forfeited alleged governments, corporations and other unwarranted alleged creditors and spendthrifts, both for FREEDOM and the Beneficiaries thereof; to accomplish the purposes of FREEDOM as long as they are not unlawful purposes under the Laws of the Creator and the Laws of Creation, and so long as it shall not dilute FREEDOM's standing;

(3.5) Continued Furthering of the Best Organizational Interests of FREEDOM: to operate within the intent of the Trust as understood by the Board of Trustees; to operate for the best organizational interests of FREEDOM when it is agreed that the Board of Trustees will not abuse, compromise, harm or injure the basic purposes of FREEDOM, nor the Beneficiaries thereof, as set forth in this instrument or properly amended by the Board of Trustees.

Article The Fourth Trustees

(4.1) The Trustees are known collectively as the Board of Trustees; there shall be up to (5) five Trustees who shall serve the entire term of FREEDOM;

(4.2) The Trustees, upon signing this contract, shall accept the Trust, and hold in ownership for FREEDOM as set forth according to FREEDOM's provisions and purposes; The Trustees shall take title to FREEDOM's assets for the purposes of protecting, converting, conserving, growing it and other purposes for the use, benefit and enjoyment for the Beneficiaries, and shall

do so under ordinary common sense applied to Trustees under express Trusts;

(4.3) The Trustees shall retain FREEDOM's assets in the actual state or condition in which they were received in Trust as much as is possible and for so long as the Board of Trustees shall deem necessary and appropriate;

(4.4) The Trustees shall hold FREEDOM's assets, any of the assets hereafter acquired, and all profits and incomes, collectively in Trust; The Trustees shall manage, administer, acquire and/or dispose of the assets and powers of FREEDOM for the sole benefit, use and enjoyment of the Beneficiaries;

(4.5) The Trustees, upon ratification of this contract, shall be deemed the Board of Trustees, and as such shall have full authority to appoint any and all Trust Officers and/or Agents as it is deemed necessary for the operations, continuance and support of FREEDOM; The Board of Trustees shall, at will, appoint and/or release any forfeited alleged government and corporation officials, employees, agents, et cetera thereof, and/or issue administrative orders to the same for such purposes as may be deemed necessary at any time; otherwise, the Trustees shall assume and exercise all the duties and responsibilities of the Trust Officers and the forfeited alleged government and corporate officials, employees, agents, et cetera thereof, until such time as the Board of Trustees may deem necessary to appoint and/or release the same;

Upon his appointment and/or acceptance the Trustees

shall have the following rights, to wit:

- (A) To retain the original FREEDOM's assets in the actual state or condition in which the same was received by the Trustees, for so long as the Trustees shall deem necessary;
- (B) To sell, alienate, convert or otherwise dispose of any of FREEDOM's assets at any time forming part of FREEDOM in such manner, by public or private contract, and for such price in monies and/or other consideration, and on such conditions as the Trustees may deem appropriate to receive the consideration, and grant discharges thereof, but only to the extent that such transactions are in the best interest of FREEDOM;
- (C) To exercise his powers on behalf of FREEDOM, and for the use, benefit, enjoyment and betterment of the Beneficiaries;
- (D) To administer exchanges of property for other property of a like or different nature, and for such consideration, and on such conditions as the Trustees shall deem appropriate and conducive to the purposes of FREEDOM; To administer the sale of FREEDOM's assets for such consideration and on such conditions as the Trustees shall deem appropriate and conducive to the purposes of FREEDOM;
- (E) To carry on any of FREEDOM's affairs, alone or in partnership, with any organization, in connection therewith, to make, execute, negotiate and arrange any and all manners of payments, any and all financial instruments of any nature, shape, cause, kind, form and format, any and all financial transactions of any nature, shape, cause, kind, form and format, and any and all other necessary authorities

with bankers and others for the benefit of FREEDOM;
(F) To consider, supervise and administer any reorganization, reconstruction or amalgamation of any and/or all of FREEDOM's assets, forfeited alleged government and corporate structures and personnel, and to consent to any dealing with such accounts as he may consider advantageous or desirable and in the best interest of FREEDOM;
(G) To invest FREEDOM's assets in such investments that he may, in his discretion, deem appropriate and desirable, in or on any part of earth whether or not the same shall be authorized for trusts; to liquidate FREEDOM's assets that he may, in his discretion, deem appropriate and desirable, at any time, and for such consideration and monies, for the sole use, benefit and enjoyment of the Beneficiaries;
(4.6) The Trustees may not at any time while holding office own or claim ownership of, or right to, any beneficial or equitable interest in FREEDOM, or any part thereof;
(4.7) The Trustees may adopt and enforce such by laws, not inconsistent with this Trust Indenture, as they may deem proper and in the best interest of FREEDOM;
(4.8) The Board of Trustees shall set up and maintain a Trust Indenture, commonly known as a contract or constitution, for the forfeited alleged governments and corporations to be confined by; this shall be styled to constrain and restrain the same from violating or infringing in any manner and way the Beneficiaries; this shall stay in full force, affect and effect until the Beneficiaries may organize themselves, effectuate their own structure and install the same; this structure may not disturb those who choose not to join thereto; In no

manner, way, shape or form shall this document and structure affect, disturb, infringe, change and/or violate the Rights, Privileges, Freedoms, Immunities, Protections and Properties of any real-man Living Soul so granted by the Creator;

(4.9) The Board of Trustees may employ by contract and pay for such professional or other assistance as they shall deem necessary and requisite in the discharge of their duties, responsibilities and authorities;

(4.10) In the event of, and upon the death, resignation or incapacity of any Trustee, the remaining shall continue to serve and shall choose and appoint a successor Trustee from an appropriate source within fourteen (14) calendar days.

Article the Fifth

Authorized Representative

(5.1) The Authorized Representative, upon appointment by the Board of Trustees, shall nominate an assistant, secretary, Treasurer, Enforcement Officers, Protector and other Trust Officers deemed proper and necessary, all of whom shall be approved and appointed with finality by the Board of Trustees; until appointments for personnel have been completed, the Authorized Representative and Board of Trustees shall handle all affairs necessary for FREEDOM; The duties and responsibilities for all Trust Officers shall be decided by the Board of Trustees, exclusively, subject only to the terms of this Trust Indenture;

(5.2) The Authorized Representative shall act as Fiduciary for FREEDOM in all dealings, public and private; The Authorized Representative, as Fiduciary and Financial Officer of FREEDOM, shall have the right and authority to sign a Title, Trust Indenture, Bill of Sale, negotiable instrument, bank check or other

financial instruments and otherwise obligate and formalize in any capacity the dealings FREEDOM, always subject to oversight by the Board of Trustees;

(5.3) The Authorized Representative shall have the authority to determine what shall constitute principal and earnings, and shall have the authority to determine when distributions will be made to the Beneficiaries, always subject to oversight by the Board of Trustees;

(5.4) The Authorized Representative shall have the authority to determine what shall constitute FREEDOM's actions in the absence of the Board of Trustees to meet; such actions will stand as permanent with the written approval of the Board of Trustees;

(5.5) The Authorized Representative shall schedule all meetings of the Board of Trustees and shall notify each of the time and location; the Board of Trustees reserves the right to meet on their own accord when deemed necessary;

(5.6) The Authorized Representative shall have all other such authority and powers as granted to him by the Board of Trustees, either verbally or in writing;

(5.7) Further, the Authorized Representative shall have and exercise the following powers, always subject to oversight by the Board of Trustees, to wit:

(A) to purchase, sell or exchange shares in any company, financial instruments, policies of assurance, other investments or property, real and personal, wheresoever situated, and take on lease for such terms as he deems appropriate on any real or personal property, whether involving liability or not, whether in possession or reversion, and whether producing income

or not, with or without security, and upon such terms as he may deem appropriate;

(B) to purchase, on and in any part of Earth, gold and silver coin and bullion or other precious metals in the same form; further, he shall have the same full powers of investing, selling and transporting the same as if he were beneficially entitled in all ways and respects to FREEDOM;

(C) to employ and pay for such professional or other assistance as he may deem necessary in the discharge of his duties, responsibilities and authorities;

(D) to perform all general acts of ownership to the same extent and with the same effect as if he were acting in the capacity of a Trustee of FREEDOM;

(E) To erect buildings on and effect improvements to any property forming part of FREEDOM, and to conduct any operations over all or part of such property;

(F) to institute and defend proceedings and to proceed to the end and determination or compromise of the same as he shall deem necessary, with written approval of the Board of Trustees;

(G) to record any financial, legal and other instruments and accounts on behalf of the Trustees;

(5.8) to pay all expenses which shall be billed directly to FREEDOM; said expenses may include, but are not limited to, the following, to wit:

(A) All costs of personnel contracted by FREEDOM and/or involved in the affairs of the same;

(B) All costs incurred in connection with organizing FREEDOM;

- the issuance, distribution, transfer, registration and recording of documents evidencing ownership by FREEDOM, or in connection with the affairs of the same; all costs, other fees and expenses paid to Trust Officers, contractors and other agents and personnel;
- (C) Reimbursement of expenses to Trustees, Trust Officers and Authorized Representative of all direct and indirect expenses of FREEDOM incurred and paid on behalf of the same; opening and maintenance of an expense account for all direct and indirect expenses of FREEDOM;
- (D) general expenses expended in connection with FREEDOM's affairs and FREEDOM;
- (5.9) Any successor Authorized Representative shall have all the powers, duties and responsibilities of the Authorized Representative hereunder;
- (5.10) The Office, power, duties and responsibilities of the successor Authorized Representative are not subject to change without the unanimous, written approval of the Board of Trustees;
- (5.11) any counsel, representative, agent, custodian or depository of FREEDOM shall forthwith become the same for the Successor Authorized Representative without the necessity of executing or filing any papers or any further act.

Article The Sixth Protector

- (6.1) The Protector shall be nominated and approved by the Board of Trustees, in writing, as an overseer of all Trust Officers, personnel and agents thereof, to ensure and enforce absolute compliance to all Clauses and Intent of this Trust Indenture and the Moral Values of the Grantor,

as evidenced by His Written Word;

(6.2) The Protector shall determine all questions and matters of doubt which may arise in the course of management, administration, realization, liquidation, partition, dissolution and operation of FREEDOM;

(6.3) The Protector shall have the duty, authority and responsibility of acting as Arbitrator to investigate and/or preside over any controversy within FREEDOM, involving Trust Officers, personnel, agents and/or Beneficiaries, so presented to the same; upon a timely and thorough investigation and/or proceeding, the Protector shall issue his Determination which shall be binding on any and all Trust Officers, personnel and agents thereof;

(6.4) The Protector may employ and pay for such professional or other assistance as he shall deem necessary and requisite in the discharge of his duties, responsibilities and authorities;

(6.5) In the event and upon the death, resignation or incapacity of the Protector, the Board of Trustees shall nominate and appoint a successor Protector within fourteen (14) calendar days;

(6.6) Any successor Protector shall have all the powers, duties and responsibilities of the Protector hereunder;

(6.7) Upon the unanimous, written approval of the Board of Trustees of the successor Protector, any professional or other assistance shall forthwith become the same for the successor Protector without the necessity of executing or filing any papers or further act;

Article the Seventh

Beneficiaries

- (7.1) The Beneficiaries shall be each and every real-man Living Soul, regardless of sex and age, domiciled on Sovereign Soil within the aforementioned Land boundaries;
- (7.2) The Beneficiaries shall receive the immediate benefits of restructuring, management, administration, liquidation, dissolution and/or operation of the forfeited alleged governments and corporations operating and/or conducting business on the Sovereign Soil within the aforementioned geographic land mass boundaries; the Beneficiaries do not own or manage any of FREEDOM's assets, but shall have full access to the properties thereof for their use and benefit; upon the completion of the dissolution of the alleged government and corporate structure, network and/or system and the first public elections, any of FREEDOM's assets not required for the operation of a Constitutional Republic or Public Trust shall be liquidated and the amount distributed equally among Beneficiaries;
- (7.3) The Beneficiaries are encouraged to act in accordance with the Grantor's Word and FREEDOM's purposes of stewardship in order to foster honorable and moral values and concepts, and to honor absolute privacy and absolute free will choice, absent injury to a real-man Living Soul or their property; FREEDOM and its Trustees, Trust Officers and other personnel shall provide such encouragement and education in the best interests of the Beneficiaries for their protection, well being, health, care, education, security and environmental safety;
- (7.4) The Beneficiaries shall have the absolute right to a redress of a grievance, relief and remedy by filing a sworn complaint

with the Protector, who shall record the same in FREEDOM's files and refer it to the Courts of Record implemented by and for the real-men Living Souls;

Article the Eighth

Powers in General, Liability

(8.1) Every discretion or power hereby conferred on the Trustees and Trust Officers shall be an absolute and uncontrolled discretion or power, and they shall thereby not be liable for any loss or damage occurring as a result of the exercise of such discretion or power, so long as such exercise is in good faith;

(8.2) Neither the Trustees nor Trust Officers shall be liable for the consequence of any error or omission, whether of law or fact, on their parts or parts of advisors or generally for any breach of duty or trust whatsoever, unless it shall be proved to have been committed, made or omitted consciously, fraudulently or in bad faith by anyone;

(8.3) The Grantor, Trustees, Trust Officers and Beneficiaries shall be held harmless against any and all claims and impositions arising in connection with FREEDOM.

Article the Ninth

Resignation of Trustee, Inability to perform

(9.1) If it shall appear to any Trustee to do so, any Trustee may resign, by instrument in writing, and the remaining Trustees shall nominate and appoint a successor Trustee, within fourteen (14) calendar days; upon the appointment of a successor Trustee, any advisor, counsel, agent, custodian and/or depository shall forthwith become the same without the necessity of executing or filing papers or any further act;

the successor Trustee shall have all the powers, duties, responsibilities and authorities of the Trustee hereunder; the successor Trustee shall, before taking Office, sign this Trust Indenture;

(9.2) If it shall appear to any Trustee that he is no longer capable of performing, that Trustee shall resign, by instrument in writing; If the Trustee cannot resign in writing, or refuses to, The other Trustee(s) may declare the Office vacant in writing and further abide by clause 9.1;

(9.3) In the event of an appointment of a successor Trustee by the Board of Trustees, it shall be declared in writing that the exiting Trustee thereupon shall cease to be the trustee in respect to and of any and all of FREEDOM, and shall immediately be divested of title to any and all of FREEDOM's assets forming any part of the same;

Article the Tenth Jurisdiction

(10.1) This Trust Indenture is made under and governed by the laws of the Creator and Laws of Creation;

(10.2) The construction and effect of every provision of this Trust Indenture shall be subject to the protection, securing and furthering of all Creator granted Rights, Privileges, Freedoms, Immunities, properties and the Laws of the Creator and Laws of Creation;

(10.3) the Original Private Venue shall have Exclusive and Original Jurisdiction at all times hereafter, excepting any contractual obligations incurred by the acts of Trustees,

and Trust Officers on behalf of FREEDOM, and all beneficial and other interest therein shall be deemed to be in the same situs, venue, jurisdiction and law form as FREEDOM.

Article the Eleventh

Release and/or Revocation of Power

(11.1) Any real-man Living Soul upon whom any power is conferred by this Trust Indenture must release any powers so conferred upon him by formal, written Notice and Declaration delivered to the Board of Trustees upon resignation or termination; upon the execution and delivery of any release pursuant to this clause, the power so released shall be absolute and irrevocable and determined so done on the date the release is delivered and attached to this Trust Indenture; in the event of failure or refusal to execute and deliver the aforementioned, the Board of Trustees shall Declare the immediate and absolute Revocation of any and all powers, and shall attach the same to this Trust Indenture;

Article the Twelfth

Permission to Restructure Trust

(12.1) FREEDOM, upon a unanimous vote and decision of the Board of Trustees, may be restructured into any other form, irrevocable in nature, that the Board of Trustees deem expedient, necessary and proper to insure the full use, benefit and enjoyment of FREEDOM's assets for the Beneficiaries, at any time during the Term of FREEDOM.

Article the Thirteenth

Durations of Trust
