I. WHAT MEDICATIONS NOT TO ACCEPT IN A HOSPITAL

Remdesivir

Morphine

Dexamethasone

Vancomycin

Hydrocodone

Lorazepam

Any anxiety Meds

No Broad-Spectrum antibiotics

II. WHAT TO DEMAND IF ADMITTED TO HOSPITAL

Ivermectin (treatment dose)

Oxygen as much as allowed

Budesonide in breathing treatment

Vitamin C Bag several times a day

Minimum of 100 mg of zinc daily

Quercetin or Hydroxychloroquine

D3, 10,000 IU's daily

Magnesium

Chest X-Ray and Spital culture to determine proper antibiotic

Determined antibiotic

III. WHAT YOU NEED TO PREVENT

D3 – 5,000 to 10,000 IU

Vitamin C – 1,000 to 5,000 mg

Zinc – 15-25 mg (take Quercetin for proper absorption into cells)

Quercetin (One hour before taking zinc)

Home-made or purchased hydroxychloroquine (Can be taken as a prophylactic or treatment)

Tonic Water (quinide)

Magnesium – 500 mg

Ivermectin (can be taken as a prophylactic or treatment)

Black Walnut (puts oxygen into the blood stream)

Saline solution to wash out nasal passages

Antiviral Mouthwash

IV. WHAT YOU NEED TO TREAT WHEN YOU HAVE SYMPTOMS

All of the above

Budesonide, Silver or food grade hydrogen peroxide

Nebulizer

Musinex

Pulse Oximeter

Pulmacort or Symbicort (enhaler for COPD)

BiPap or use a Cpap if you have one

Dandelion leaves and roots (make a tea)

HOW TO RESCUE YOUR LOVED ONES FROM HOSPITAL PRISON

- 1. Demand to be by the side of your loved one. Demand to see the medications and dosages that your loved one has been administered every day. You need all of the medical records.
- **2.** If hospital refuses you to let you into the hospital, call the local sheriff and ask them to escort you into the hospital.
- **3.** If your local sheriff refuses to perform his constitutional duty, your only recourse is to pull your loved one out.
- 4. Call the hospital patient advocate and tell them that your loved one wants to die at home and you want to call in hospice. They should immediately make arrangements for transportation to your home and also set up the equipment at your home. You must do this before a vent is required. If you wait too long, they will not make the trip home. Be sure that you have made arrangements for a doctor that will treat your loved one with the proper healing protocol and you have all of the above items ready to go.
- 5. Be sure that every step is documented with a video or live stream. Be loud, be strong, be confident. You are fighting for the life of your loved one and they are depending on you to take care of them. Warn them that you will continue to file charges, and will blast out to the nation that this hospital is murdering your loved one. Let the treating doctor know that you will be filing a law suit against him personally along with the hospital. Reach out to everyone you know to put it on their social media.
- **6.** Do not let the doctors or administration trick you into believing they will change. They will not. Hospitals are a business. It is all about money not saving lives.
